

June Crime Report

Assault:

June 1st

- 3043 Nutley St, Fairfax (Safeway & CVS): Officers responded for a shoplifting. The offender walked into the Safeway and became disorderly and shoplifted merchandise. The store manager stopped the offender after passing all points of sale with the unpaid merchandise. The offender dropped the items and began throwing watermelons at the store manager before walking over to the CVS and stealing merchandise from there. The offender was arrested.
- 7500 block of Idylwood Rd, Falls Church: The victim was walking home from school when he was hit with “Orbeeze” pellets. An unknown vehicle was shooting the “Orbeeze” pellets randomly and recklessly as it drove down the street. One of the pellets hit the victim in the leg.

June 3rd

- 8461 Leesburg Pike, Vienna (Chick-fil-A): The victim was sitting in the dining room when the offender came in and pepper sprayed the victim and punched him in the face. The victim was able to get a license plate, which led to the identification of the offender. It was verified that the vehicle owner was the same individual in the video from Chick-fil-A). The offender was charged with assault.

June 8th

- Porter Rd/Stillwood Cir, Falls Church: The victim followed the offender into a parking lot because of a road rage incident. After a verbal argument the victim tried to leave but the offender blocked the victim from leaving. The victim tried to use the car door to push the offender back, but the offender punched the victim. Charges are pending.

June 12th

- 1500 Cornerside Blvd, Vienna (Walmart): Lost Prevention was alerted to a disorderly customer. When the LPO tried to mediate the disorderly customer, the customer sat on the counter yelling while knocking items off. When the LPO told the customer he needed to leave, the customer began throwing avocados at the LPO. The disorderly customer left the scene before police arrival.

June 14th

- 8298 Glass Aly, Fairfax (MOM's Organic Market): The victim was putting groceries in his vehicle when he was approached by the offender. The offender pepper sprayed the victim and called him a racist. The offender stated that he had done it because the victim coughed on him twice and the victim was a racist. The victim stated he has never seen the offender while in the store. Warrants are on file for the offender.

June 20th

- 2200 block of Gallows Rd, Dunn Loring: The victim was attempting to pull out of a parking space when he was almost hit by the offender who was allegedly speeding. A verbal argument ensued before the victim walked off and entered the store. The offender followed the victim and pushed the victim inside the store.

- 2985 District Ave, Fairfax (The Press): An employee arriving to work noticed clothes that were lying on the ground. Overnight the suspect entered through an unlocked door and stole clothing that was to be dry cleaned. While the cameras for the business were not operational a possible suspect was developed based off Mosaic security cameras.

Burglary (Residential):

June 1st

- 6600 block of Weathford Ct, McLean: The homeowners were out of town for the weekend. When they returned home, they noticed a light that was left on. Since they had closed and locked all the doors and shut off all the lights, they believed something was odd. As they entered the house and walked towards the kitchen, they noticed the family room door had been smashed with a bottle that was normally kept on the deck. The closet and drawer in the master

bedroom had been ransacked. Jewelry was stolen. Their home did not have an alarm system and the camera was not working.

June 3rd

- 1163 Orlo Dr, McLean: The homeowners were out of town and received a notification on their phone of a man on the back patio. When she received the notification, she called the police which prevented her from watching the video footage live. Once the officers arrived on scene, they searched the house with negative results. The master bedroom drawers and closet had been ransacked. The homeowner stated she keeps all her valuables in a safe. There does not appear to have been anything stolen. The case is still under investigation.
- 7800 block of Langley Ridge Rd, McLean: Officers were dispatched to a residential alarm. While walking along the exterior of the home they noticed a railing that was propped up against the side of the house just underneath a second-floor patio. Continuing their search, they discovered a rear patio door smashed. The second-floor window was smashed. The master bedroom closets and drawers were ransacked. It appears the suspects used the railing by climbing up to the second-floor patio to gain entry. The case is under investigation.

June 11th

- 6500 block of West Langley Ln, McLean: When the homeowners returned to their home from being out of town, they discovered the second-floor French patio doors had been smashed which leads into the master bedroom. The room was ransacked. The home did not have a security system.

Destruction of Property:

June 2nd

- 1321 Chain Bridge Rd, McLean (McLean Family Restaurant): The victim's vehicle was parked in the parking lot. When the victim returned to her vehicle, she discovered the driver's side rear door had been keyed.

June 7th

- 6600 block of Mayfair Dr, Falls Church: Red spray paint was sprayed on a Toyota 4Runner while parked overnight.

June 21st

- 9400 block of Lee Hwy, Fairfax: The passenger window of a Dodge Challenger was smashed.

- 7600 block of Ledford St, Falls Church: A Toyota and Honda sedan parked in the parking lot had the tires slashed.

Narcotics/Weapon:

At this point officers began arriving on scene. During the investigation, it was discovered that Offender #1 was in possession of narcotic drug paraphernalia indicative of distribution. Offender #1 was charged with carrying a concealed weapon (machete) and Offender #2 was charged with Possession with Intent to Distribute a Scheduled 1 or 2 narcotic and drug paraphernalia.

ROBBERY:

June 26th

- 8500 block of Leesburg Pike, Vienna: The victim had returned from DC and stopped at the Exxon. As he was walking back to his vehicle, he observed 4 males armed with what was described as a Glock style semiautomatic firearm. The suspects chased the victim back into the store and demanded all his belongings. The victim gave the suspects the jewelry he was wearing, watch and car keys before the suspects fled the scene.

Stolen Auto:

The offender got into the victim's vehicle and sped off driving over a curb and losing control. The victim gave chase and as the victim got closer the offender pepper sprayed the victim.
